



Board Performance Evaluation for Charities And IPCs

Introduction

This course is to assist Charities and IPCs in the understanding and consequently managing some of the major issues involved when considering how to carry out board performance evaluation. Different issues will apply to different charities and IPCs. It is the aim of this course to trigger the thought processes so that boards/management councils/committees may consider for themselves the issues that are appropriate to their own and their organisation's circumstances.

In leading up to these decisions, it can be useful to take a step back and try to identify the requirements of a board, management council/committee and the elements which need to be in place to achieve optimum performance.
