This seminar will take participants into the world of tax evasion. Participants will hear true life stories about what happened to tax evaders, why they get caught, and how they are punished. Participants will also learn about what they can do if they are placed under investigation. The number of cases being investigated by IRAS has risen each year and the severity of the punishment imposed by the courts have also increased.

This seminar is aimed at owners of businesses, (i.e. sole-proprietors, partners and/or directors of private limited companies). Hopefully the stories will help them resist the temptation to evade, often brought about because they listen to the wrong "friends" and are misguided by these "friends".

Mr Goh joined IRAS (then known as the Inland Revenue Department, Singapore) in 1969. He was retired from IRAS on 1 Mar 2005. He is a CPA Singapore, FCPA Australia, FCCA UK and ACIS a member of SAICSA.
